### Terms and Conditions

1. The sealed bid should be addressed to:

2. Along with the bid form and terms and conditions, bidders will have to deposit an earnest money of 10% of the total bid amount. The earnest money can be calculated as below:

*Offer rate X required quantity X 10% for each of the items quoted*

3. The earnest money shall be in the form of Cash or Demand Draft addressed to the Bhutan Duty Free Limited, Thimphu.
4. The earnest money of the successful bidders will be retained until the bidder deposits the full bid amount. The earnest money will be adjusted against the auction value of the items won by the bidder.
5. The earnest money of unsuccessful bidders will be returned immediately after completion of the evaluation of sealed bid.
6. The bidders can bid for any items depending on their required quantity subject to our stock availability as given below:

- iv. Gold Flake King Regular.....1 Cartoon (50 Gums)

7. All successful bidders while lifting their lots need to check the quantity of products before leaving the premises. No complaints whatsoever will be entertained thereafter.
8. The successful bidders will have to deposit the full bid amount within 3 (three) working days from the day the tender committee accepted the bid and take the delivery of the items at their own cost. Failure to do so will result in the forfeiture of the earnest money and the bid will no longer be valid. The tender committee reserves the right to award to the next highest bidder.
9. In the event the successful bidder fails to lift the goods within the stipulated deadline, the second highest bidder will be given the option to lift the said goods who will be given another 3 (three) days to lift the goods from the date intimated to the bidder. Likewise similar procedures can be followed till the stock lasts.
10. In the event any successful bidders refused to lift the goods within the stipulated deadline, the tender committee may allocate the goods to the next highest bidder.
11. The tender committee reserves the right to accept or reject the bids without assigning any reason whatsoever. In case of any dispute or problem with regard to the auction, the decision of the committee shall be final and binding.
12. The mere act of submission of bid implies that the bidder accepts without questions the terms and conditions. The BDFL shall assume that interested parties bidding for items have inspected the lots prior to the auction and that the bid offered is at their own liberty and judgment. No complaint will be entertained at a later date.
